The list shows the relevant firms by jurisdiction, beginning with the United States and then continuing alphabetically. As the Board has previously described, because of asserted restrictions under non-U.S. law or objections based on national sovereignty, access to the information necessary to conduct inspections of registered firms has been denied, and continues to be denied, in certain non-U.S. jurisdictions.
